






Terms & Conditions:

I understand that the SportsPlex will not be held responsible for any of my/my group's belongings and I agree that I will not hold the SportsPlex responsible for any damage or theft of my/my group's property in or outside of its facilities.
4. I agree that the SI SportsPlex will not be responsible for any personal injuries or losses sustained by me or members of my party while on premises. I further agree to indemnify and hold harmless the NY Carousel Entertainment, Ride Entertainment Parks & Attractions, the City of New York, the New York City Department of Parks and Recreation and their successors and assigns, from any claim, action, liability, loss, damage or suit, from any claims or demands arising out of such injuries or losses.

5. I understand that children within my rental group must always be within eyesight and hearing of an adult over the age of 18. I understand that adults are responsible for the supervision and safety of children during the rental times.
6. I give permission to the SI SportsPlex to photograph my event for publicity purposes. SI SportsPlex may print and/or display those pictures..
7. I understand that the rental information included in this packet is binding to my rental agreement.
8. The SI SportsPlex reserves the right to refuse play or service to anyone.
9. Any fighting will result in permanent banishment from the facility.
10. **Insurance (if determined as required by the SI SportsPlex):** Applicant has, and shall maintain, throughout the term of this agreement, general liability insurance, naming the following as additional insureds with an amount coverage not less than \$2,000,000 per occurrence, including personal injury and property damage: NY Carousel Entertainment, LLC and the City of New York/NYC Department of Parks & Recreation. Prior to the use of the property, Renter agrees to deliver to the SI SportsPlex the required COI(s) and provides that the insurance company must provide the SI SportsPlex with at least ten (10) days prior written notice of any cancellation or reduction in coverage.
11. **Cancellation Policy:** All payments, including deposits, are non-refundable. Customers are responsible for full payment of all rentals within thirty (30) days from the date of cancellation. Customers will be exempted from this responsibility if the SportsPlex is able to resell the cancelled time. It is the responsibility of the customer to find out if the time was resold. Deposits are non-refundable even if the time is resold. If a customer cancels outside the (30) day period, then any payments greater than the deposit will be refunded in full.
12. If the facility is closed for any reason, customer shall receive a facility credit toward a future rental date. If no dates are available, customer shall receive a refund only for those dates in which the facility was closed.
13. Please be courteous of others. When your time is complete, promptly leave the court or field of play so that the next rental can use the space. It is the responsibility of the customer to end their rental time at the allotted time. Anyone who continues to practice or play after their time has been completed will be billed and may forfeit their rights to future rentals at the SI SportsPlex.
